The following articles were denied from JPay messaging on 3-10-2020: Rebecca Boone, "U of I professor sues Idaho for Execution Records," and Tommy Simmons, "Idaho Faces Another Lawsuit Over Lethal Injection Secrecy." I've never before had a JPay message withheld, consider this unnecessary censorship, and I feel it serves no penological interest.

I have tried to solve this problem informally by:

Requesting reason for denial from investigations.

I suggest the following solution for the problem:

Explain why these articles were censored and retrain staff to allow the flow of public information between offenders and media.

I reviewed this matter with IMSI investigations concerning the confiscation of J-pay correspondence.

The correspondence you referenced was not confiscated but was returned to the sender. Therefore, I was not able to review the correspondence. However, the investigative sergeant advised that the content of the correspondence was concerning an inmate currently classified with a sentence of death.

This type of correspondence is not allowed and was appropriately returned to the sender.
