JPay message confiscated 9-6-20 for encouraging violence was reporting violence, not encouraging it. I am disturbed that this is becoming a patter. Riots happen in prison. Deaths happen in prison. Just because they're reported doesn't meant they're encouraged. Censoring media coverage is not okay.

I have tried to solve this problem informally by:

Additionally, no attention was given to my request to further train Mr. Roe, who helps highlight the need for it in his initial response: He himself says "there is no way of knowing the intent of the sender and if it is meant to share media coverages or to encourage the same violence in IDOC facilities." This directly contradicts the reason he provided on the message's confiscation form, which stated as a fact that the send was "encouraging violence in prison." Please identify the root of Nathan's confusion, address it, and let the communication through as Nicholas Baird has so kindly instructed. Thank you.
